# MENTORSHIP OVERVIEW

---

## Brief

The Colorado Young Leader Mentorship Program was established in 2014 by the Colorado CoreNet Global Board of Directors as a means to raise the level of engagement and broaden a Young Leaders' perspective of membership and educational benefits. The Mentorship Program is the best opportunity to have access to some of the most experienced corporate real estate professionals in the rocky mountain region, where one can connect and build lasting relationships and be provided personal advice on how to get the most out of your corporate real estate career.

## Program Details

- All mentors and mentees are required to attend the kickoff event
- All mentor / mentee pairings are to meet for a minimum of 1 hour per quarter
- All mentors and mentees are required to attend 75% of all CoreNet Programs for the duration of the program
- All mentees are required to attend 75% of CoreNet Young Leader events. If the mentee is a corporate real estate professional, then they may attend the corporate real estate round tables in lieu of the young lead events when running simultaneously.

## Eligibility

Mentees must be of age 35 and/or under for the entire calendar year of 2015  
Must live within the Colorado Chapter Region (Colorado, Montana, Idaho, North Dakota, South Dakota, or Wyoming)  
Must be physically able to attend the events outlined above  
Must be a current CoreNet Global member or will become a CoreNet Global member (costs not included)

## Submission Requirements

1. Complete the application form, including Applicant Information and Applicant Essays
2. Attach a current headshot
3. Provide applicant information in a single PDF file via email to [coloradochapter@corenetglobal.org](mailto:coloradochapter@corenetglobal.org)

## Selection Criteria

The Mentorship Selection Committee will review all complete submissions and selections will be made at the sole discretion of the selection committee along with CoreNet Board approval. Judging of the complete submissions will be based on the content of the application and statement of interest as outlined above in the "Submission Requirements". We suggest specific information on all background and goal information. This is a critical item that the Selection Committee will use to make the final selection.

## Selection Schedule

1. Application submission deadline is 8/28/15
2. Selections of all participants by Selection Committee by 9/11/15
3. Mentors / Mentees pairing from 9/28/15 to 10/9/15
4. Duration of program from 11/2/15 to 11/1/16
5. Mentorship Program kickoff event is TBD
