 - define what CRE does well today
 - research what CRE can learn from other industries
 - recommended reading (e.g. Thomas Davenport "Analytics at Work" or "Enterprise Analytics at Work")
 - look how other industries address capacity planning (airports, hotels, universities)
 - identify what tools are best-practice or leading-edge
 - to ask ourselves if we are confident that we are asking the right questions
 - identify where the challenges and gaps are gathering the appropriate data
 - explore technology opportunities to illustrate data more effectively to analyze options and present value-driven solutions

Meeting Notes

- 1. The preferred method of communication is an email and a direct link to a file document (in lieu of attaching a large file). Webinars and conference calls are effective but make provisions to document in some format for those who are not able to attend at the schedule time.
- 2. The recommended reading that was discussed at the Big Data & Analytics' round table at the Orlando Summit was "Analytics at Work" ("Enterprise Analytics" by Thomas Davenport. It would be great to have a 1 or 2-page summary of the significantly relevant points from the book.
- 3. Eleanor confirmed that CNG members have access to the SPP microsite even if they weren't formally affiliated with the SPP Community.
- 4. The Technology Task force, led by Charemon Tovar, has a survey that is ready for distribution to SPP members. We should review the content to see what our group might leverage from the results and if there might be an opportunity to add another question or two that would be pertinent to our research.

- 5. Research topics were discussed and the most popular
 - a) Are we looking for the right output and information so we know to ask the right questions?
 - b) Identify tools that can help visualize the data for better scenario analysis and presentation
 - c) Research what other industries have done with Big Data & Analysis what can we learn and apply to CRE?
 - d) Existing Data how can ensure that it isn't stale? What are the opportunities for the data we already have?
- 6. Based on feedback from members on the call and input from previous discussions, the issue that seemed to resonate with most was to understand the outputs CRE needs so we know what questions to ask. Dave and Clay offered to co-lead an effort to focus on the "are we looking for the right output?" Comments about this topic:
 - a) Too much is focused on "bread and butter" metrics: SF / person, cost / SF, people / seat,
 - b) How can we relay this information to executives for decision-making?
 - c) Are we measuring the right things?
 - d) Are we comparing apples to bowling balls?
 - e) Some information is more harmful than good
- 7. Whatever path this group takes, one of our goals is to elevate the relationship between the end user and service provider.
